Dear Weekday Preschool Parents,

It is now looking like we will not be able to complete our school year. I am so very sad about that. I have loved getting to know and teach your precious babies! I miss seeing them! We take so much for granted. Who would have ever guessed that something like this would happen? You know that it's possible, you just don't think it *will* happen. At least that's how I am.

I have been researching government guidelines that we must follow to prepare for re-opening our campus. We must take great care to keep everyone safe and healthy. We don't plan to meet for corporate worship until June. It does seem, though, barring the pandemic getting any worse than it is now, I will be able to offer a summer camp for 7 weeks during June and July. I have been working to prepare some fun themes and activities. What I need to find out is how many would be interested in having their child attend. It would be held Tuesdays and Thursdays, from 9:00 am -12:00 pm, beginning on June 2.

Below are steps I must take to ensure compliance with the governor's executive order for our program. Some of these steps will be in preparing our classroom, while others steps are required daily. Because each day of camp has a different theme, I will not use our normal classroom set up. The shelf units in the room will be turned facing the wall, because the things on those shelves are not needed for camp. I will bring in daily the items needed for that day's theme. Automatically, this lowers the number of things in the room to be sanitized.

Our room will be thoroughly sanitized prior to the beginning of camp, including the carpet being cleaned. In addition to this are daily requirements:

- Group sizes are limited to 10, including the teacher and a helper. So no more than 8 children per class.
- Access will be restricted to staff and children. This means children will be dropped off at the door to the facility. Parents/siblings will not enter.
- You will sign your children in and out at the door, using your own pen.
- Staff and children will be screened prior to entrance and will be excluded if they have a fever above 100.4 or exhibit respiratory symptoms, including cough or shortness of breath. Staff conducting daily screenings will wear appropriate PPE. We have on staff at LBC a retired nurse who will be doing these screenings.
- On campus we will only be in our room, or on the playground. We will take care to sanitize the playground daily prior to playtime.
- We will be extra vigilant and diligent in matters of hygiene, sanitation and disinfection, taking care to clean surfaces and objects that are frequently touched including door knobs, classroom sink handles, countertops, toilets (after each use), tables, and chairs.
- Toys will be disinfected prior to use and as needed during use.

I am enclosing a flyer with the details about camp. We will also offer Mother's Morning Out during this same time, but we will not be sharing space or going to the playground at the same time. They will have the same student limit per classroom.

If you think that you would be interested in this for your child, would you please text me at 960-6729 no later than **May 15th**. Be sure to leave your name. I will need to know at least by then so I can order supplies. I will need at least 5 to participate daily to make this feasible. Thank you!
